Civil Society speakers for the Civil Society Task Force (CSTF) Hearings in New York and Vienna.

Deadline: 9 January 2019 at 11:55 p.m. CET.

The Civil Society Task Force (CSTF), a joint initiative of the New York and Vienna NGO Committees on Drugs, will hold two Global Civil Society Hearings at the United Nations - one in New York and one in Vienna - to support preparations for the forthcoming Ministerial Segment of the Commission on Narcotic Drugs (CND)

The Civil Society Hearings are titled "Voices fo Civil Society: Beyond 2019" and will be held in late January or early February (the exact dates are still to be determined, and will be communicated as soon as possible).

The goal of the Global Civil Society Hearings is to update member states on CSTF activities, in particular the results of the Global Civil Society Consultation, as well as to provide valuable inputs from civil society experts from around the world, and to allow space for a dialogue between civil society and policy makers

Balkan project – Choose Recovery

Highlights from the midterm report - highlights are taken from the midterm report

The World Federation Against Drugs is together with three organisations Proslavi Oporavak in Bosnia and Herzegovina, Preporod in Montenegro and Restart Serbia in Serbia, carrying out a project in Balkan region, in Serbia, Bosnia and Herzegovina and Montenegro. All member organisations are working in drug addiction field in areas of motivation for treatment and re-socialization after treatment as the primary focus of their organisations.

The overall project objective is to strengthen the society's responses towards people who use drugs and people affected by drug abuse and thereby improve their position in society. The project is a continuation of a pilot project that was conducted during 2015 and the first month of 2016 which aimed to map the needs of the societies and also to assess the possibility to deepen the cooperation between state and the civil society in this field.

Based on the mapped needs of the societies a project was planned stretching from 2017-2020. Below are some highlights from the midterm report from this joint Project:

The project has seen a great success since the onset and throughout. Since its initiation, a free telephone helpline and Substance Abuse Community Counselling Centre, SACCC, have been established in the three countries and promoted in national and regional media. In order to increase the outreach in the countryside of the three countries, and to make the services more visible and accessible partner have used many channels for promotion, including posters and leaflets.

The organisations also initiated a Facebook campaign and campaigns through the health care system, social welfare institutions, and the police. In Bosnia and Serbia, posters are displayed in many hospitals and mental health institutions, at different police stations as well as NGOs working with youth, families and vulnerable- and at risk populations, as well as the Employment Agencies across the region. The phone line and the SACCC are working on the principles of confidentiality and anonymity for all, so people can ask for help without fear of stigmatization. The Centre is functioning with trained staff during past fifteen months and people with substance abuse problem are seeking help more than before, according to statistics and data base of phone calls.

The organisations assessed that emphasis should be placed on early interventions, as the majority of people who call the helpline are parents of young people. After the assessment the organisations also involved school staff in their multi-sector meetings and received inspiring feedback and commitment from the school psychologists and social workers.

The World Drug Day 2018 is a day of rare occasion, when the public and media's attention is focused on illicit drug use and addiction. The campaign carried out for World Drug Day was assessed as very successful, and was carefully prepared to promote the telephone helpline and SACCC. To increase the scope of their impact and to mark the day on Social Media and web portals, the organisations produced several promotional materials such as a shot 29-second film, a 4-minute animation of public opinion and research as well as a radio jingle.

Making a difference?

The project assessment is that their work during the past period has made a significant impact on the project's target group. Their first and most important target group, people with substance abuse problems and their families, now have direct access to the organisation's services.

During the period 1 June 2017- 20 September 2018, the organisations provided a total of 1082 services (phone calls and in-person meetings) o different active users, individuals in recovery as members of their families.

Prevent - don't - promote

President Statement 61st Session CND

On December 5-7th 2018, the Reconvened Intersessionals with the Commission on Narcotic Drugs were held in Vienna.

WFAD President Esbjörn Hörnberg called for nine focus points: The Way Forward; Mobilize a Million Communities; Priorotise early intervention and assistance to vulnerable groups; Offer treatment, rehabilitation, and harm-reduction alternatives; Organise local support systems after specialised treatment; Support self-help Groups for drug users and those in recovery; Support alternative development; Develop and implement alternatives to incarceration; and Implement the principle of proportionality in sanctions.

WFAD President concluded by stating that drug use is a multifacited problem with biosocio-psychological origin: "That is why Civil Society can bring powerful results when it

addresses all these elements on various levels. Civil Society has the advatage of being more flexible, of being rooted among people - those it serves and in understanding the structures of governance in their country. Those are strong tools for solving the problem and creating the change we want to see in the World."
